Minutes of the meeting held on 8<sup>th</sup> March 2019 at 2:00PM at Tower B 2<sup>nd</sup> Floor ATRIUM. The following decisions were agreed upon by mutual consent by the members present. An unregistered Society is being floated initially, which will be formalized and legalized in about 3 months of time after rectification of current issues/concerns.

1. All the members (Owners/Tenants) will be required to compulsorily fill a registration form (will be floated via website by early next week) and registration fee of INR 500/- has to be paid in cash for the first funding of the association and activation of the website secure login. The accounting details will be available on the website.
2. The Maintenance and Parking invoices raised by M/s Grandslam Developers Pvt Ltd. (Builder) are not to be paid till a final decision is given by the Legal Committee of iTHUMOWA (Association). Those who have received the invoices shall keep them and won't receive any further invoice from the **Builder** with regards to the same.

Initial formation of the Finance, Legal, Press & Media, Coordination and Cultural committees for kick starting the activities of the iTHUM OWA. **Any volunteer who is willing to join and contribute to the committee is welcome. It was agreed that the Committees are formed on Six monthly rotational basis for wider participation and sharing of the responsibilities.**
